The *Government of the Arab Republic of Egypt* has received financing from the World Bank toward the cost of the *Emergency Food Security & Resilience Support Project*, and intends to apply part of the proceeds toward payments under the contracts for *Design, construction, manufacturing, supply, installation, provision of spare parts sufficient for 3 years, commissioning, training, start-up and handing over of grain storage corrugated metal silos and handling facility systems in Toshka site*. For this contract, the Borrower shall process the foreign currency payments using the Direct Payment disbursement method, as defined in the World Bank's Disbursement Guidelines for Investment Project Financing, while the EGP payments shall be made directly by EHCSS.
2. The *Egyptian Holding Company for Silos and Storage (EHCSS)* now invites sealed Proposals from the following initially selected eligible Applicants for *Design, construction, manufacturing, supply, installation, provision of spare parts sufficient for 3 years, commissioning, training, start-up and handing over of grain storage corrugated metal silo and handling facility systems in Toshka site with storage capacity 300,000 metric tons (completion period of 24 months) on a single responsibility turnkey basis* one lot. The procurement will be conducted through international competitive procurement using Request for Proposals (RFP) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" *edition September, 2023* ("Procurement Regulations"), and is open to all initially selected eligible Proposers.

 6. The RFP document will be *delivered to Applicants by hand and by email as a PDF document.*
 7. A single-stage, two envelopes RFP process will be used, and the Proposal will consist of (i) the Technical Part, without any reference to prices; and (ii) the Financial Part, as detailed in the RFP Document. The Technical and Financial Parts of the Proposals shall be submitted simultaneously in two separate sealed envelopes.
 8. The Proposal, both the Technical Part and the Financial Part, must be delivered to the address below on or before 10:00 Cairo time (GMT +3) on **August 11, 2024**. Electronic Procurement *will not* be permitted. Late Proposals will be rejected. The Technical Part of the Proposals will be publicly opened in the presence of the Proposers' designated representatives and anyone who chooses to attend at the address below on 10:00 Cairo time (GMT +3) on **August 11, 2024**. The Financial Part shall remain unopened and will be held in safe custody of the Employer until the second public opening of the Financial Part, following the evaluation of the Technical Part of the Proposals.

9. All Proposals must be accompanied by a “*Proposal Security*” in one of the following two options (at the choice of the proposer):
 - a. *Option 1: USD 480,000 (Four Hundred and Eighty Thousand USD) and LE 15,000,000 (Fifteen Million Egyptian Pounds).*
 - b. *Option 2: USD 750,000 (Seven Hundred and Fifty Thousand USD).*
10. All Proposals must be accompanied by a Sexual Exploitation and Abuse (SEA) and/or Sexual Harassment (SH) Declaration.
11. Attention is drawn to the Procurement Regulations requiring the Borrower to disclose information on the successful Proposer’s beneficial ownership, as part of the Contract Award Notice, using the Beneficial Ownership Disclosure Form as included in the RFP document.
